

EC-TMC meet turns stormy; CEC, party trade charges

CLAIMS OF MP 'SHOUTING', CEC ASKING THEM TO 'GET LOST'

A Trinamool Congress delegation's meeting with the Election Commission on Wednesday to raise issues related to SIR in West Bengal saw acrimonious exchanges, with the party leaders claiming the Chief Election Commissioner asked them to "get lost" and the poll panel accusing them of "shouting".

The meeting, which barely lasted seven minutes, was followed by a terse statement from the Election Commission (EC), saying it gave a "straight-talk" to the Trinamool Congress (TMC) delegation that "this time, the elections in West Bengal would surely be: fear-free, violence-free, intimidation-free, inducement-free".

The TMC delegation - comprising its Rajya Sabha leader Derek O'Brien, deputy leader Sagarika Ghose, MPs Saket Gokhale and Menaka Gururamany - met the full bench of the Election Commission

Will move court again against voter deletions: Mamata

KOLKATA: West Bengal Chief Minister Mamata Banerjee on Wednesday hit out at the BJP and the Election Commission over voter deletions during the SIR exercise and said her party will move a court again to resist the removal of electors from the rolls. Her comments came after nearly 91 lakh voters' names were deleted from the electoral rolls following the completion of the Special Intensive Revision in the state. "You will not be able to defeat the TMC by deleting names. We will move a court again to resist the exclusion of names," Banerjee said while attacking her principal challenger BJP over the roll revision exercise.

Banerjee had in February argued in the Supreme Court as she sought an intervention in the SIR process. The EC figures, which pushed the total deletion to over 90.83 lakh names from the original voter base of 7.66 crore in October 2025, showed that the proportion of removal of electors now remains at over 11.85 per cent.

EC sources accused O'Brien of shouting at the election commissioners and said that he asked Chief Election Commissioner (CEC) Gyanesh Kumar not to speak. "The CEC requested Derek O'Brien to maintain decorum in the commission room. Shouting and indecent behaviour are not appropriate," they said.

After submitting their memorandum, the TMC leaders told the CEC that they did not want just words, but action on the ground, party sources claimed, adding the CEC accused O'Brien of speaking loudly and told them to "get lost".

Khera moves Telangana HC for anticipatory bail

Congress leader Pawan Khera on Wednesday moved the Telangana High Court seeking anticipatory bail in a case filed against him by the Assam government on his allegations against Chief Minister Himanta Biswa Sarma's wife.

Khera, who showed his residential address in Hyderabad, requested the court to release him on bail in the event of his arrest. The petition was filed on April 7. It will be taken up by the court on April 9.

Khera named the DCP of Guwahati Crime Branch Police Station and Telangana government as respondents to his petition. The case was registered against Khera under several sections of the BNS, including 175 (false statement in connection with an election), 35 (Right of private defence of the body and of property) and 318 (cheating).

3 of banned outfit held for Manipur bomb attack

Three suspected members of a proscribed outfit have been arrested in connection with the bomb blast at Tronglaobi in Manipur's Bishnupur district that killed two children, police said on Wednesday.

The arrests have been made in Churachandpur district, a police statement said.

Violence broke out in Manipur's Bishnupur district on Tuesday as two children were killed in the bomb attack on their home, while two others were shot dead when a mob stormed into a CRPF camp during a protest against the blast.

On Wednesday, police said, "In various operations launched in the aftermath of the Tronglaobi incident, three cadres, suspected to be of the

United Kuki National Army (UKNA), were arrested in Churachandpur District with arms and ammunition."

Those arrested have been identified as Jampao Kuki, Sasang and Paulleml Vaiphai, police said, adding that an AK-47 rifle with 25 bullets, a pistol with 15 rounds, Rs 20,100 cash, and two sacks of raw opium weighing 21.19 kg were seized from them.
