

Murder attempt case filed against Khan Sir for 'asking guards to shoot'

witnesses claimed the duo was seen firing "two rounds each" from rifles.

Police allegedly contacted Khan, who confirmed that the two men were his private security guards, and said the rifles used were licenced weapons procured through a Noida-based APS security agency.

The guards were eventually arrested and allegedly told investigators that on the night of June 2, a group had gathered outside the coaching institute, assaulted guard Chun Chun, tore banners at the gate, raised slogans and created a disturbance.

"Seeing the crowd, Khan Sir and his unidentified aides told both of us security personnel — 'what are you looking at, shoot at the crowd immediately, I'll handle whatever happens,'" the complaint records the guards as reportedly telling investigators, adding they fired "two rounds each".

The latest FIR came a day after police had publicly stated that CCTV footage and local inquiries had yielded no evidence of firing during the June 2 attack.

An FIR based on Khan's complaint led to the arrest of three persons linked to the rival Gyan Bindu Coaching Institute, including its director Raushan Anand. On Friday, Khan was unavailable for a comment.

Kumar of Kadamkuan police station on June 4 said that police began verification after videos and photos purportedly showing firing outside KGS circulated on social media.

"People nearby identified the two individuals seen in the video as private security guards of KGS/ Khan Sir," the complaint said, adding that

Delhi court orders framing of charges in terror case against top PFI leaders

OBSERVING THAT there was a "grave suspicion" of a conspiracy to overthrow the Indian government and establish an Islamic Caliphate in the country by 2047, a Delhi court on Friday ordered framing of charges in a terror case against the top leaders of the banned Popular Front of India (PFI).

"Considered as a whole, the material on record raises grave suspicion that the accused, acting through and on behalf of the Popular Front of India and its National Executive Council (NEC), agreed and acted in furtherance of a single conspiracy — to overthrow the secular democratic Government of India and to establish an Islamic Caliphate under Sharia law in India by or before

the year 2047 through an armed struggle against the State." Additional Sessions Judge Prashant Sharma said in his order.

The NIA's case, lodged in 2022, pertains to allegations that PFI "conspired to overthrow the secular democratic Government of India" and to establish an Islamic Caliphate under Sharia law in India by or before 2047.

The agency had claimed that the PFI's objective was to be achieved "through armed struggle against the state". "Each accused's role, on the material at face value, fits into one or more limbs of the conspiracy," Judge Sharma said, ordering framing of charges against PFI and 25 other accused persons. Formal framing of charges will take place on July 10 following which trial is likely to begin against all the accused persons.

Himachal ex-dy AG booked on former chief secy Gupta's complaint

POLICE IN Himachal Pradesh Friday booked former deputy advocate general Vinay Sharma for defamation and criminal intimidation, following a complaint by former chief secretary Sanjay Gupta.

The FIR was registered at the Chhotia Shimla police station under sections 248 (fabricated or baseless criminal charges or the explicit intent to injure or harass someone), 351 (criminal intimidation) and 356(2) (criminal defamation) — based on a complaint filed by Gupta on May 30, who accused Sharma of making false allegations of corruption, abuse of office, benami property holdings, illegal use of funds and administrative interference.

Gupta, in his complaint, described claims by Sharma in a police complaint against him on March 24 as malicious and intended to damage his reputation. Sharma, a 1988-batch IAS officer, superannuated as Himachal Chief Secretary on May 31 and subsequently joined as the chairperson of Punjab State Electricity Regulatory Commission (PSERC) on June 3.


According to the FIR, the police headquarters examined allegations levelled by Sharma and found them to be "incorrect, legally untenable, unsupported by documentary evidence, and based on assumptions and conjectures". Responding to the FIR, Sharma alleged that the action was politically motivated and intended to discourage him from pursuing legal action against Gupta. "I was not called even once to record my statement."

Nepal's Foreign Minister Shisir Khanal reaches Delhi, begins visit to India

New Delhi: Nepal's Foreign Minister Shisir Khanal arrived in India Friday for a three-day official visit. This is the first visit by a minister from Nepal's new government formed in 2025, led by Prime Minister Balendra Shah.

Khanal is scheduled to hold talks with External Affairs minister S Jaishankar on Saturday after which he will depart on Sunday.

The visit comes days after Nepal's ruling Rastriya Swatantra Party chairman Rabi Lamichhane visited India earlier this week. Sources said that the issues of development partnership, economic assistance and cooperation in the power sector are expected to be on top of the agenda for discussion between Khanal and Jaishankar.
